General Information:

The Rules of Golf as adopted by the United States Golf Association govern play. This information sheet, the USGA Hard Card and any site-specific Local Rules and Conditions of Competition sheets are supplements to the Rules of Golf. Local Rules of the host course do not apply.

Format & Qualifying Positions:

18 holes of stroke play qualifying. The three (3) players with the lowest score will advance to the 2022 U.S. Senior Amateur Championship. There will also be two (2) alternate positions available.

Should you qualify, you must accept your position and pick up the proper credentials prior to leaving the qualifying site. Any ties for the last qualifying position or alternate positions will be determined by a sudden-death playoff beginning immediately after the conclusion of play.

Play-Off:

In the event of any tie for the last qualifying place or any of the alternate positions, the players concerned shall compete in a sudden death play-off to begin immediately following the conclusion of the round.

Schedule of Events:

Monday, July 18, 2022 – Qualifying (18 Holes)

Practice Round:

Practice rounds are available on weekday afternoons at the clubs discretion. The cost of a practice round will be \$40, includes the use of a cart and **must be paid by cash only, no credit cards will be accepted.** Arrangements may be made by contacting a member of the Black Hall Club professional staff at (860) 434-2038.

Registration:

When you arrive at the Club, please check in at the reception table, located outside of the clubhouse.

Practice Range:

The practice range will be available for your use beginning at 7:30am and is courtesy of the CSGA.

Course Setup:

Black Hall Club will play as a par 71 at approximately 6,450 yards with a time par of 4 hours and 30 minutes. For practice round purposes players should play the black tees with the exception of holes 3, 8 & 12 where the blue tees should be played.

Attire:

Proper golf attire is required at all times by players, caddies and spectators. Shorts must be Bermuda length. Shirts must have a collar and be tucked in. Jeans of all kinds, cargo pants/shorts, tee shirts and tank tops are prohibited. Hats must be worn in a traditional manner.

Footwear:

Shoes with traditionally-designed spikes (regardless of composition, i.e., ceramic, plastic, etc.) or spikes, regardless of design, comprised either entirely or partially of metal (if such metal may come in contact with the course) are prohibited during the stipulated round. See Model Local Rule G-7 in Section 8 of the Official Guide to the Rules of Golf.

Caddies & Transportation:

A player may carry his own bag, employ a caddie and/or use a golf cart. There are no club caddies available at the host club. The use of push/pull cart is permitted. The cost of a cart is **\$25 and must be paid by cash only** in the golf shop prior to your round.

Note Regarding Golf Carts:

For the U.S. Senior Amateur the USGA has adopted the "one-seat" policy. The player and/or the caddie may operate the golf cart but are prohibited from riding in the cart at the same time. In addition, players will be required to share a golf cart when more than one player in each group has opted to ride.

Driver Heads & Golf Balls:

Only brands of golf balls on the most current List of Conforming Golf Balls and driver heads on the most current List of Conforming Driver Heads may be used. See Model Local Rules G-1 and G-3.

One Ball Rule:

Model Local Rule G-4 is in effect. During an entire round, each ball at which the player makes a stroke must be the same brand and model as found in a single entry on the current List of Conforming Golf Balls.

Groove Specifications Condition:

In qualifying and in the Championship proper, the Local Rule as prescribed by Section 8 of the Committee Procedures is in effect. Model Local Rule G-2.

Withdrawals:

You must contact the USGA Championship Department at (908) 234-2300 or the CSGA at (860) 257-4171 if you must withdraw from this qualifier. A competitor who fails to notify either the USGA or CSGA of his withdrawal may be subject to disciplinary actions by the USGA.
