General Information:

The Rules of Golf as adopted by the United States Golf Association govern play. This information sheet, the USGA Hard Card and any site-specific Local Rules and Conditions of Competition sheets are supplements to the Rules of Golf. Local Rules of the host course do not apply.

Format:

18 hole qualifier of stroke play. The number of players advancing will be made available on the day of the qualifier.

Grouping and Starting Times:

Starting times will begin from the 1st tee at 7:30 am

Practice Round:

Practice rounds are available weekdays at any time and weekends after 1:00pm. The cost of a practice round will be \$45 including a cart. Please call the Golf Shop at 203-268-0707 to book your round.

Registration:

Players must check in at the player registration table located in front of the Golf Shop.

Practice Range:

The practice range will be available at the course the day of the tournament starting at 7:00 am. Range balls cost \$7, \$13 or \$18 depending on the bucket size.

Caddies & Transportation:

A player may carry his own bag, bring his own caddie, use his own pull cart or rent a riding cart at a cost of \$20.

Attire:

Proper golf attire is required at all times by players, caddies and spectators. Shorts must be Bermuda length. Shirts must have a collar and be tucked in. Jeans of all kinds, cargo pants/shorts, tee shirts and tank tops are prohibited. Hats must be worn in a traditional manner.

Footwear:

Rule 4.3a is modified in this way. Shoes with traditionally-designed spikes (regardless of composition, i.e., ceramic, plastic, etc.) or spikes, regardless of design, comprised either entirely or partially of metal (if such metal may come in contact with the course) are prohibited during the stipulated round. Penalty for breach of this condition is disqualification.

Food & Beverage:

Lunch and drinks will be available at the restaurant.

Distance Measuring Devices:

A player may obtain distance information by using a device that measures distance only. If, during a stipulated round, a player uses a distance-measuring device that is designed to gauge or measure other conditions that might affect his play (e.g., gradient, wind speed, temperature, etc.), the player is in breach of Rule 14-3, for which the penalty is the General Penalty for the first breach and Disqualification for a second breach.

Withdrawals:

You must contact the CSGA at (860) 257-4171 if you must withdraw from this championship. A competitor who fails to notify the CSGA of his withdrawal may be subject to disciplinary actions.
