



This notice to players supplements the CSGA Local Rules and Conditions of Competitions, which may be found on the Blackhawk Country Club Women's One Day tournament portal.

PACE OF PLAY: The CSGA Pace of Play policy will be in effect for this One Day event. Players are expected to complete their round in 4 and a half hours. Please play "ready golf" as outlined in the 2023 Rules of Golf.

FORMAT: 18-hole stroke play with gross and net competitions. **TEES:** All women will play from the Red tees.

HANDICAP INDEX: The June 20th Handicap Index will be used for all handicap purposes.

SCORING: Official scoring will be done through the Golf Genius Mobile Scoring App. All players need to proceed to the scoring area immediately after the completion of play to verbally certify your score with a member of the CSGA staff. This verbal process is equivalent to signing your scorecard.

<u>OUT OF BOUNDS</u>: Identified by white lines, white stakes or boundary fences on every hole. In the absence of white stakes, there are lamp posts which designate out of bounds on the left (condo) side of every hole (tee to green). The lamp post is out of bounds. All paved roads and parking lots are also out of bounds. A ball crossing a road or parking lot area and coming to rest on another part of the golf course is still out of bounds.

<u>PENALTY AREAS</u>: Identified by red lines and/or stakes on Hole #1, 3, 5, 16, 17 & 18. When both stakes and lines are present, stakes identify the penalty area and lines define the penalty area.

HOLE #9: The entire wooded area on the right side of the 9th hole is an environmental area played as a red penalty area, however you are <u>not</u> permitted to play your shot from the area. Beyond the wooded area is a parking lot which is out of bounds. If it is not known or virtually certain the ball is in the penalty area it must be treated as lost or out of bounds.

<u>GROUND UNDER REPAIR</u>: Areas defined by white lines on the ground are considered to be Ground Under Repair. Free relief is available as prescribed in Rule 16-1.

<u>IMMOVABLE OBSTRUCTIONS</u>: The monument (rock and plaque) on the right side of Hole #16 green, and the concrete pad and patio on the right side of Hole #9, are both immovable obstructions. Free relief is available as prescribed in Rule 16-1.

HOLE#5: Free relief may be taken from the drainage area to the right of the 5th fairway (drop one club length from nearest point of relief, no nearer the hole).

NO PLAY ZONES: Decorative flower beds and cultivated areas on the left side of the condos on every hole are "no play zones" from which free relief is mandatory.

PRIZES: Top finishers will receive merchandise credit redeemable at the Blackhawk C.C. Golf Shop. Prize certificates will be emailed to the recipients and need to be redeemed during the 2023 golf season. In addition, the winners and second place finishers in the gross and net divisions will earn invitations to the Al Acker One Day Championship at Lake of Isles on October 10^{th.}
