This letter will acknowledge receipt and acceptance of your qualifying application. You have selected to qualify at Woodway Country Club in Darien, CT on Monday, May 6<sup>th</sup>. Pairings and other site specific information can be found under the qualifying tab on the CSGA website

### **General Information:**

The Rules of Golf as adopted by the United States Golf Association govern play. This information sheet, the CSGA Hard Card and any site-specific Local Rules and Conditions of Competition sheets are supplements to the Rules of Golf. Local Rules of the host course do not apply.

### **Schedule of Events:**

Monday, May 6<sup>th</sup>, 2024 – Qualifying Round, 18 holes stroke play.

### **Qualifying Positions:**

The number of qualifying positions for both the Connecticut Amateur and Russell C. Palmer Cup will be posted the day of the qualifier.

### **Grouping & Starting Times:**

Starting times begin at 8:00am from the first tee.

### **Practice Round:**

Practice rounds are available after 1:00pm on April 24<sup>th</sup>, 25<sup>th</sup> or May 1<sup>st</sup>. **The fee for a practice round will be \$30 cash only** and includes a riding cart. Please call the Golf Shop at 203-322-2362 to make a reservation.

### **Registration:**

Players must check in at the player registration table located in front of the golf shop upon their arrival.

### **Practice Range:**

The practice range will be available for your use beginning at 7:00am. Balls are the courtesy of Woodway Country Club.

### **Caddies & Transportation:**

A player may carry his own bag, employ a caddie, or rent a golf cart. While the use of a golf cart is permitted during the qualifier, the cost is not included in your entry fee. If you wish to utilize a golf cart, please check in with the Golf Shop upon your arrival. Woodway Country Club does not permit the use of personal hand carts. **The cost of a riding cart will be \$30 per player and must be paid in cash. The cost of a push cart will be \$25 and must be paid in cash**

### **Attire:**

Proper golf attire is required at all times by players, caddies and spectators. Shorts must be Bermuda length. Shirts must have a collar and be tucked in. Jeans of all kinds, cargo pants/shorts, tee shirts and tank tops are prohibited. Hats must be worn in a traditional manner.

### **Footwear:**

Shoes with traditionally-designed spikes (regardless of composition, i.e., ceramic, plastic, etc.) or spikes, regardless of design, comprised either entirely or partially of metal (if such metal may come in contact with the course) are prohibited during the stipulated round. Penalty for breach of this condition is disqualification.

### **Food & Beverage:**

Food and beverage, **on a cash basis only**, is available starting at 11:30am. Players, caddies, and spectators are responsible for any food and beverage fees incurred during their round.

### **Driver Heads & Golf Balls:**

The optional conditions as prescribed in Appendix I of the Rules of Golf are in effect.

### **Withdrawals:**

You must contact the CSGA at (860) 257-4171 if you need to withdraw from this qualifier. A competitor who fails to notify the CSGA of his withdrawal may be subject to disciplinary actions by the CSGA.
