General Information:

The Rules of Golf as adopted by the United States Golf Association govern play. This information sheet, the USGA Hard Card and any site-specific Local Rules and Conditions of Competition sheets are supplements to the Rules of Golf. Local Rules of the host course do not apply.

Schedule of Events & Format:

Wednesday, April 24, 2024 – Qualifying Round (18 Holes of stroke play)

Qualifying Positions:

The number of players advancing to final qualifying will be posted when it becomes available. There will also be two (2) alternate positions available. Should you qualify, you must accept your position and pick up the proper credentials prior to leaving the qualifying site.

Play-Off:

In the event of any tie for the last qualifying place or any of the alternate positions, the players concerned shall compete in a sudden death play-off to begin immediately following the conclusion of the round.

Practice Round:

Practice rounds are available on a first come first serve basis between April 16th and April 23rd. The cost of a practice round is \$100 and includes the use of the practice facility for one hour prior to the starting time and a golf cart or push cart. Personal push carts are **NOT** permitted during the practice round. Players are permitted to bring up to 3 guests at cost of \$179 per player. Caddies:

The use of a caddie is permitted but not required. TPC River Highlands does not have any club caddies available.

Automotive Transportation:

The use of a golf cart during the round is **prohibited**.

Pull Carts:

The use of a push/pull cart is **permitted**.

Course Setup:

TPC River Highlands will play to a par 70 at approximately 6,800 yards with a time par of 4 hours and 34 minutes.

Registration:

Players must check in at the player registration table located in front of the Golf Shop upon their arrival.

Practice Range:

The practice range will be available for your use beginning at 6:30am. The cost for range balls is courtesy of the CSGA. Please adhere to the posted distance restrictions.

Attire:

Proper golf attire is required at all times by players, caddies and spectators. Shorts must be Bermuda length. Shirts must have a collar and be tucked in. Jeans of all kinds, cargo pants/shorts, tee shirts and tank tops are prohibited. Hats must be worn in a traditional manner.

Footwear:

Shoes with traditionally-designed spikes (regardless of composition, i.e., ceramic, plastic, etc.) or spikes, regardless of design, comprised either entirely or partially of metal (if such metal may come in contact with the course) are prohibited during the stipulated round. Penalty for breach of this condition is disqualification.

Distance Measuring Devices:

The use of a distance measuring device is permitted.

Driver Heads:

Model Local Rule G-1 is in effect. Any driver the player uses to make a stroke must have a clubhead, identified by model and loft, which is on the current List of Conforming Driver Heads issued by the USGA.

Groove & Punch Mark Specifications:

Model Local Rule G-2 is in effect. In making a stroke, the player must use clubs that conform to the groove and punch mark specifications in the Equipment Rules that took effect on January 1, 2010.

Golf Ball

Model Local Rule G-3 is in effect. Any ball used in making a stroke must be on the current List of Conforming Golf Ball issued by the USGA.

One Ball Rule:

The One Ball Rules is NOT in effect for local qualifying.

Pace of Play:

The pace of play policy as adopted by the Connecticut State Golf Association will be in effect.

Withdrawals:

You must contact the USGA Championship Department at (908) 234-2300 or the CSGA at (860) 257-4171 if you must withdraw from this qualifier. A competitor who fails to notify either the USGA or CSGA of his withdrawal may be subject to disciplinary actions by the USGA.
