



Qualifier – 90th Connecticut Open

General Information:

The Rules of Golf as adopted by the United States Golf Association govern play. This information sheet, the CSGA Hard Card and any site-specific Local Rules and Conditions of Competition sheets are supplements to the Rules of Golf. Local Rules of the host course do not apply.

Schedule of Events:

Tuesday June 25, 2024 – Qualifying Round (18 holes of stroke play)

Qualifying Positions:

Players with the low 7 scores, including ties, will advance to the 2024 Connecticut Open.

Grouping & Starting Times:

Starting times will begin at 8:00am from the first tee.

Practice Round:

Practice rounds are available on most days. To schedule a practice round please call the CT National Golf Club golf shop at (860) 928-7748. The cost of the practice round is \$55 to walk and \$75 to ride, Monday to Thursday.

Course Setup:

Connecticut National GC will play to a par 71 at approximately 6,900 yards with a time of 4 hours and 23 minutes.

Registration:

Players must check in at the player registration table located in front of the golf shop upon their arrival.

Practice Range:

The practice range will be available beginning at 6:30am. Range balls courtesy of Ct National GC.

Food & Beverage:

The restaurant located adjacent to the golf shop and clubhouse will be open beginning at 11:30am. The cost of food and beverage is not included in the entry fee.

Locker Room:

There is no locker room at the course.

Caddies:

A player may carry his own bag or employ a caddie. Players are responsible for any fee incurred for the use of a caddie. There are no club caddies available through CT National GC. Players are entitled to employ a caddie and use a golf cart with the only restriction being that of the cart limit cart outlined in the "Golf Carts" section of this notice.

Golf Carts:

The use of a cart is permitted but not included in your entry fee. Each starting time is limited to one cart per twosome or two carts per threesome. The cost of a golf cart will be \$20 and can be paid in the golf shop.

Attire:

Proper golf attire is required at all times by players, caddies and spectators. Shorts must be Bermuda length. Shirts must have a collar and be tucked in. Jeans of all kinds, cargo pants/shorts, tee shirts and tank tops are prohibited. Hats must be worn in a traditional manner.

Footwear:

Rule 4.3a is modified in this way: During a round, a player must not wear shoes with traditional spikes (that is, spikes having single or multiple points designed to penetrate deeply into the surface of the ground (regardless of whether made of metal, ceramic, plastic, or other materials)) or spikes of any design that are entirely or partially made of metal, if such metal may come in contact with the course.

Driver Heads & Golf Balls:

Local Rule G-1 and G-3 are in effect. A player must not make a stroke with a clubhead or golf ball that is not on the current listing of the USGA List of Conforming Driver Heads or List of Conforming Golf Balls. Penalty for breach of this Rule is disqualification.

Withdrawals:

You must contact the CSGA at (860) 257-4171 if you must withdraw from this championship. A competitor who fails to notify the CSGA of his withdrawal may be subject to disciplinary actions.
