General Information:

The Rules of Golf as adopted by the United States Golf Association govern play. This information sheet, the USGA Hard Card and any site-specific Local Rules and Conditions of Competition sheets are supplements to the Rules of Golf. Local Rules of the host course do not apply.

Schedule of Events:

Tuesday, June 25th, 2024 – Qualifying Round (18 holes of stroke play)

Qualifying Positions:

All players will play 18-holes of Stroke Play Qualifying. Players with the low 14 scores, plus ties, will advance to the 90th Connecticut Open Championship on July 29-31 at Shorehaven Golf Club in Norwalk, Connecticut.

Grouping & Starting Times:

Starting times will begin at 8:30am from the first tee.

Registration:

Players must check in at the player registration table located outside of the golf shop upon their arrival.

Practice Round:

Practice rounds are available on any day. You must go online at hsrgolf.com to make your reservation. Available times are Monday thru Sunday. The rates are \$35 Monday thru Thursday and \$38 on weekends. Carts are an additional \$18.

Practice Range:

The practice range is located on Hoyden's Hill Rd. Go past club entrance & turn left at stop sign. Range is ½ mile on right. PLEASE leave enough time to go to range & be back for your tee time. You MUST go there by your car. No access from the club.

Caddies & Transportation:

You may bring your own caddie, carry your own bag, use a push cart or use a riding golf cart. The cost of a cart is \$18.00 per person per round. There will not be any caddies available at the club

Food & Beverage:

The restaurant will be open at 7:30 for breakfast, snacks & lunch.

Attire:

Proper golf attire is required at all times by players, caddies and spectators. Shorts must be Bermuda length. Shirts must have a collar and be tucked in. Jeans of all kinds, cargo pants/shorts, tee shirts and tank tops are prohibited. Hats must be worn in a traditional manner.

Footwear:

Shoes with traditionally-designed spikes (regardless of composition, i.e., ceramic, plastic, etc.) or spikes, regardless of design, comprised either entirely or partially of metal (if such metal may come in contact with the course) are prohibited during the stipulated round. Penalty for breach of this condition is disqualification.



Distance Measuring Devices:

For all play in CSGA events a player may obtain distance information using a device that measures distance only. If, during a stipulated round, a player uses a distance measuring device that is designed to gauge or measure other conditions that might affect his play (e.g., gradient, wind speed, temperature, etc.), the player is in breach of Rule 14-3, for which the penalty is the general penalty for the first offense and disqualification for a subsequent offense.

Driver Heads & Golf Balls:

The optional conditions as prescribed in Appendix I of the Rules of Golf are in effect.

Withdrawals:

You must contact the CSGA at (860) 257-4171 if you must withdraw from this championship. A competitor who fails to notify the CSGA of his withdrawal may be subject to disciplinary actions.
