General Information:

The Rules of Golf as adopted by the United States Golf Association govern play. This information sheet, the CSGA Hard Card and any site-specific Local Rules and Conditions of Competition sheets are supplements to the Rules of Golf. Local Rules of the host course do not apply.

Schedule of Events:

Thursday, August 22, 2024 – 18 holes of Four-Ball stroke play. In case of a tie for the Championship there will be a hole-by-hole play-off immediately following the conclusion of play.

Grouping & Starting Times:

Starting times begin at 7:00am from the first tee. Play will be from the CSGA tee markers.

Practice Round:

Practice rounds are available for \$50 including a cart, and players may bring a guest. To schedule a practice round, please call the Wallingford CC Golf Shop at (203) 284-2189.

Course Setup:

Wallingford Country Club will play as a par 71 at approximately 6400 yards with a time par of 4 hours 30 minutes.

Registration:

Players must check in at the player registration table located in front of the golf shop upon their arrival.

Practice Range:

The practice range will be available for your use beginning at 6:00am. Please note that the range is strictly **irons only**.

Food & Beverage:

The CSGA will provide lunch for all participating players.

Caddies & Transportation:

Players are prohibited from using a caddie during the stipulated round. The use of automotive transportation is mandatory and included in the entry fee.

Attire:

Proper golf attire is required at all times by players, caddies and spectators. Shorts must be Bermuda length. Shirts must have a collar and be tucked in. Jeans of all kinds, cargo pants/shorts, tee shirts and tank tops are prohibited. Hats must be worn in a traditional manner.

Footwear:

Shoes with traditionally-designed spikes (regardless of composition, i.e., ceramic, plastic, etc.) or spikes, regardless of design, comprised either entirely or partially of metal (if such metal may come in contact with the course) are prohibited during the stipulated round. Penalty for breach of this condition is disqualification.

Driver Heads & Golf Balls:

The optional conditions as prescribed in Appendix I of the Rules of Golf are in effect.

Withdrawals:

You must contact the CSGA at (860) 257-4171 if you must withdraw from this qualifier. A competitor who fails to notify the CSGA of his withdrawal may be subject to disciplinary actions by the CSGA.
