

# EXEMPT PLAYERS

Exempt players must meet the entry eligibility criteria and submit an application prior to the entry deadline.

## CATEGORIES

- 1) Past Champions of the following events: Connecticut Amateur, Connecticut Open, Russell C. Palmer Cup, Connecticut Mid-Amateur, Connecticut Public Links, Connecticut Senior Amateur, Connecticut Senior Match Play, New England Amateur and/or New England Senior Amateur.
- 2) Players who advanced to the round of 16 in the 2024 Connecticut Senior Match Play
- 3) The top 15 players in the 2024 Connecticut Senior Amateur
- 4) The top 15 players in the 2024 Dick Siderowf Senior Player of the Year rankings
- 5) Players who successfully qualify for a USGA Championship (including US Open Sectionals) in either 2024 or 2025
- 6) The 2024 Super Senior Gross Champion
- 7) Mill River Country Club will receive two exemptions to use at their discretion
